**1. Voices of the Koas**

**2. Public Comment**

John Moody reiterated he would like the Commission to consider the revision of criteria 1 of the application process for a tribe to become state recognized. He also provided the Commission members with documents of prior policy regarding site burial protection and sacred places. Additionally, he spoke about the wind farm project in the Southern Green Mountains. He along with several others, are composing letters to dissuade the project from resuming.

Dale Azaria, VT DHCD, commented on the status of the application process for the open and upcoming vacancies on the Commission. The deadline for the two current vacancies is May 15, 2015. She also reported that there are no age restrictions for applicants, youth can apply to become Commission members. In light of this new information, the Division for Historic Preservation (VDHP) will be accepting applications for the upcoming Commission vacancies. The deadline for these applications will be July 1, 2015. Dale also informed the Commission, members cannot be on the interview panel, but can provide the Division with questions to ask at the interviews.

**4. Approve March 11, 2015 minutes**

**OLD BUSINESS**

**1. Cultural Environmental Conference (Charlie Megeso)**

Topic was tabled until next month.

**2. Action Plan**

**a. Abenaki Heritage Gathering**

Shirly Hook reported that planning was continuing to go well for the gathering, with the exception of losing the food vendor. Walker Brook, Andrew Beaupré and John Moody provided Shirly with alternative food vendor ideas. Shirly plans on contacting Charlene McManis to check the status of advertising and marketing for the event.

**b. Archaeological Process**

Andrew Beaupré advised there are no new updates regarding the archaeological process since his last report. He will set a meeting with Jess Robinson to discuss the policy further.

**c. Abenaki Artifacts Guidelines / d. Anti-looting on Abenaki Artifacts**

Andrew Beaupré mentioned at a prior Commission meeting, Dale Azaria had agreed to look into NH law. Dale recollected she had done some research a few months back and had spoken with the NH State Archaeologist. The NH State Archaeologist advised about the importance of building alliances with different war groups and history preservationists to help in the preservation and protection of artifacts. Additionally, she advised as part of VT law, there are criminal penalties for anyone trafficking artifacts.

**e. Native Youth College Program**

Walker Brook advised that he has not received any feedback or interest from the tribes. The Commission members were concerned that the information about the scholarships and the UVM Summer Happening program may not be reaching enough people. Commission members discussed different ways and means of reaching more native people.

**f. VCNA Youth Representation**

This topic was discussed during agenda item 2 public comment.

**g. Abenaki Cultural Heritage Week**

Topic was tabled until next month.

John Moody advised that the NH Commission on Native American Affairs is meeting in Hanover on Tuesday, May 19, 2015. He also advised of an Abenaki language gathering over the Memorial Day weekend.
