1. Voices of the Koas

2. Public Comment

Jess Robinson extended an offer to the Commission in regards to Vermont archaeology month in September. If the Commission as a whole, or if individuals would like contribute, please let him know.

John Moody expressed his concern over the proposed Iberdrola wind project in the southern Green Mountain forest. He encouraged Commission members to explore the site in order to have a better understanding of the project.

Rich Holschuh inquired as to the Commission's stance on reports such as the Truth and Reconciliation Commission (TRC) report that just came out of Canada and a similar report from Maine. The Truth and Reconciliation Commission members in Maine were appointed to investigate the treatment of indigenous children in the foster care system, and similarly in Canada, to investigate the treatment of indigenous children in boarding schools. These reports contained troublesome information, and Rich was interested in the Commission's viewpoint. Several Commission members felt very strongly in regards to this topic and there was discussion of putting the topic on the agenda for future meetings.
