Meeting Minutes**

Lucy Cannon-Neel stated she continues to see an increase in communications with the tribes and is appreciative to everyone who has helped to make this goal become a reality.

**c. Native Traditions Conference**

Lucy Cannon-Neel thanked Melody Brook for her invaluable assistance in planning the conference. Additionally, Ms. Cannon-Neel stated she has received positive feedback concerning the upcoming conference, with interest from possible attendees from the other New England states. Print, television, and Facebook advertising have been completed and an agenda for the conference will be forthcoming.
